NorthEast Chiropactic Council Leadership Grant

1- Why was the N.E.C.C. Leadership Grant program established ?

The N.E.C.C. wishes to acknowledge the work each State Association /Council/ Society (organizations) does advancing the profession's mission.

In addition, the N.E.C.C. recognizes the importance of developing your organizations leadership skills for both its current and future members.

To that end, the N.E.C.C. established this grant to provide resources that can be used by the organization to fund tuition and or travel expenses to leadership training conferences.

2- Who is eligible to receive the NECC Leadership Grant ?

To be eligible to receive the N.E.C.C. Leadership Grant, the organization must be a member of the NorthEast Chiropactic Council in good standing.

In addition, the individual(s) who is attending the leadership training conference must be a member of the organization that is applying for the grant.

3- How much is the Grant?

The N.E.C.C. will reimburse the organization up to \$500.00. per leadership conference per calendar year.

4- How do I apply for the N.E.C.C. grant?

To receive the N.E.C.C award the organization must complete the application found within this brochure. Email, Fax or mail the information to the N.E.C.C. contact.

The funds will be reimbursed to the organization upon receipt of expense documentation (e.g. tuition receipt, ground, air, meals, tolls,) The reimbursable expenses may not exceed \$500.00 per leadership conference.

5- What are the organizations responsibilities ?

At the organizations discretion, they may either submit a one page synopsis of the conference that focuses on the areas that the attendee found most relevant and applicable to the organization or attend an N.E.C.C. meeting where they will report directly to the members.
